

Ghana Badminton Disciplinary Regulations Sanctions Effective November 23, 2022

The decision as to the appropriate sanction to impose following disciplinary proceedings is for the relevant Disciplinary Hearing (or Appeal) Panel. When considering the sanction, the suitable Panel must have regard to this Sanctions Guidance in totality.

When applying this Guidance, the Panel should remember that the disciplinary process should ensure any sanction reflects the seriousness of the incident, action or behaviour. Any sanction imposed must be the least necessary to support the integrity of Badminton, uphold appropriate standards, protect those involved in the sport, and institute measures for the sporting ecosystem.

While every case must be treated on its own merits, the table below describes the range of sanctions available for various types of behaviour. While we expect that we will impose sanctions within the relevant Acceptable Sanction Range, in exceptional circumstances, the Panel may impose a more or less severe sanction where this is necessary to reflect the seriousness of the incident, action or behaviour.

In deciding sanction, the Panel must first identify the level of offence. The table below is indicative and does not provide an exhaustive list of types of behaviour- and general misconduct under Articles 33 and 47 of the Constitution. Where it is not explicitly covered in the table below, breaches of Codes or Policies may be assessed at any level depending on the seriousness of the violation.

Discriminatory behaviour Sexual harassment Breach of safeguarding policy/guidance (risk to others) Abuse of drugs and alcohol. Ghana Badminton will assess all action's seriousness by considering the following:

- The level of culpability
- Any harm caused
- Aggravating Factors
- Mitigating Factors

While not an exhaustive list, the following are examples of aggravating and mitigating factors that may be present:

Failing to take responsibility for actions	The previous moral character I no previous disciplinary findings
Lack of insight or remorse Repeat of	Genuine remorse or insight
previous conduct Discriminatory	Personal circumstances (including health issues)

Under the influence of alcohol or substance

Breach of confidentiality	
Attempting to cover up or conceal inappropriate conduct	
Attempting to cover up or conceal inappropriate conduct	

Where an individual or group fails to prove that Ghana Badminton have failed to comply with Ghana Badminton Codes or Policies, the following sanctions should apply:

Level 1	 Written warning Temporary suspension of Ghana Badminton membership for a maximum of 12 months
Level 3	 Temporary suspension of Ghana Badminton membership for a maximum of 24 months Termination of Ghana Badminton membership Deduction of points Relegation, exclusion or disqualification from competitions
