### **Notice to All Stakeholders**

We encourage all clubs, shared interest groups, and not-for-profit organizations to share this notice within their networks. Full details are also available on the Ghana Badminton website.

Per Article 5 of the Ghana Badminton Association Constitution, membership fees are annual subscriptions to be paid each year by a set date (Article 5.2, 5.3). Clubs are therefore required to pay their fees for the current season to maintain 'good standing' (Article 3.2.7a).

Please note: Outstanding fees from previous years are cumulative and attract interest penalties (Article 5.5). Furthermore, a 10% monthly penalty automatically applies to any subscription unpaid one month after its due date (Article 26.1.5). To avoid these penalties and maintain eligibility for competitions and voting rights, please ensure your club's annual subscription is paid promptly.

### **Planning Ahead for 2026**

Clubs and groups are reminded to follow the sanctioning processes outlined on our website when planning events, development programs, workshops, and competitions.

### **Membership Benefits**

As outlined in **Article 4 of the Ghana Badminton Constitution**, registered members gain access to structured benefits and privileges designed to support growth and participation, subject to fulfilling all registration requirements.

### **Database Modernization Initiative**

Membership fees will support the automation and centralization of our national participant database, improving service delivery and governance for all registered athletes and officials.

### **Financial Planning Note**

Clubs are advised to incorporate this fee into their 2026 financial planning. Timely registration ensures uninterrupted access to membership benefits and competition eligibility.

### **6. ONGOING MEMBERSHIP REQUIREMENTS**

13.1 Every Affiliated Member shall submit to the Secretary-General every quarter in each calendar year a completed Schedule A which includes the number of its registered players as at a date within the preceding three (3) months. BAG shall have the right by 30 March in the same year to refuse to accept such declarations representing the number of registered players and also, if no Schedule A has been received, to assess the figures on such information as shall be available. An Affiliated Member shall have the right to object to BAG against such assessment within fourteen (14) ordinary days of the decision. The onus of proof shall lie with the Affiliated Member concerned.

The contact information in Schedule A will be used for daily communication with the Affiliated Member, with the Chairman as the primary contact person.

- a. To keep its membership status, an Affiliated Member shall at all times fulfil all the conditions necessary for admission to membership (Articles 4 and 5) and promptly advise the Association of any material change in its status.
- b. An affiliated Member must always be bound by the Statutes of the Association.
